Dear Mayor Bowser:

On March 7, 2019, Amber Crowder, a former District government employee, was sentenced in the United States District Court for the District of Columbia (USDC) to 13 months incarceration; 24 months of supervised released; a \$2,500 fine; and ordered to pay a \$100 court assessment fee for defrauding the District of Columbia Public Schools (DCPS). In addition, the court ordered Ms. Crowder to forfeit a money judgement in the amount of \$19,164 to the United States Marshal Service (USMS).

On February 5, 2019, Shauna Brumfield, a member of the public, was sentenced in the USDC to 1 year and 1 day incarceration; 24 months of supervised released; a \$2,500 fine; and ordered to pay a \$100 court assessment fee for also defrauding DCPS. In addition, the court ordered Ms. Brumfield to forfeit a money judgement in the amount of \$43,293 to the USMS.

An OIG investigation revealed that from October 2012 through March 2014, Ms. Crowder and Ms. Brumfield engaged in a scheme to defraud DCPS by bid-rigging a government contract valued at nearly \$300,000. On November 26, 2018, Ms. Crowder and Ms. Brumfield pled guilty to one count each of Mail Fraud, in violation of 18 U.S.C. § 1341.
